J U D G M E N T

The petitioners have filed this application Under Section 28 of Special Marriage Act, 1954 for divorce by mutual consent.

2. The case of the petitioners in brief is that their marriage was solemnized before the Marriage Officer Khurda at Bhubaneswar on 01.05.2008 vide Ext. 1. After marriage, they did not live together as husband and wife for a single day though they are officially husband and

wife. Due to differences arose between them which could not be resolved and as such they have been living separately since 01.05.2008 and they have no physical relation since the date of marriage as at the time of marriage the petitioner No. 2 was continuing her B.V.Sc & A.H. under O.U.A.T, Bhubaneswar and residing at Srujankia Girls Hostel of OUAT and petitioner No. 1 was residing at his parent's house. Therefore, they have been living separately more than six years. The petition was filed on 08.04.2013. It is further averred that several attempts have been made by the family members, friends and well wishers for their reunion but in vain. As chance of reunion was remote they decided to dissolve the marriage by mutual consent.

3. Both the petitioners were examined in oath as P.Ws. 1 and 2 respectively. They have stated unanimously that their marriage was solemnized on 01.05.2008 before the Marriage Officer Khurda at Bhubaneswar vide Marriage Certificate No. 269/2008. After the marriage, due to indifferent temperament, and mental incompatibility and difference opinion they have been living separately since 01.05.2008. Although their friends and relatives tried their best to reunite them, reconciliation was not possible. The chance of reunion is remote and having no other alternative both of them decided to dissolve the marriage by mutual consent.

4. Petitioner No. 2-wife in her evidence has stated that she has no claim of any alimony for past, present and future. In view of above admission by the petitioner No. 2, she is not entitled to get any alimony from petitioner No.1. The petition was filed on 08.04.2013. The petitioners are in the prime period of their youth. Both of them stated on oath that they have been living separately since 01.05.2008 and they have not been able to live together and they have mutually agreed that their marriage should be dissolved. The Court should not stand bar to their future life. The petition of the petitioners succeeds. Hence, it is ordered;

ORDER

The petition for divorce by mutual consent is allowed. A decree of divorce is passed and the Marriage Certificate bearing No. 269/2008 is cancelled and the marriage between the petitioner No. 1 and petitioner No. 2 is hereby declared dissolved with effect from the date of decree.
